**ADMINISTRATIVE ORDER 95-2 Appointment of Intake Screening Team**

---


Pursuant to Colorado Rules of Juvenile Procedure 3.7 and the general authority of the Colorado Children's Code Title 19, CRS:

IT IS HEREBY ORDERED: that the Montrose County Intake Screening Team is authorized to operate a Juvenile Intake Screening Program for the counties of MONTROSE, OURAY AND SAN MIGUEL. Properly trained personnel of the INTAKE SCREEN TEAM shall be designated as the authority to determine whether a child taken into temporary custody in the above counties should be released to parent, guardian or other legal custodian, or admitted to a detention, temporary holding or shelter facility pending notification to the district court as to the schedule of a detention hearing. The program shall be operated between the City of Montrose and Division of Criminal Justice.

IT IS FURTHER ORDERED that the sheriff's departments and police departments in Montrose, Ouray and San Miguel Counties should, to the best of their abilities, consult and cooperate with the INTAKE SCREENING TEAM and may do so for the purposes of the intake screening process by telephone at any hour of the day.

IT IS FURTHER ORDERED that in determining if a juvenile requires detention, the INTAKE SCREENING TEAM shall follow criteria for the placement of juvenile offenders, which criteria are established in accordance with CRS 19-2-1602.
