**Appointment of Members to Juvenile Planning Board**

**Recitals**

- A. Pursuant to CRS 19-2-211 all Boards of County Commissioners having approved the creation of a Juvenile Planning Board for the 7<sup>th</sup> Judicial District, and;
- B. The Chief Judge of the 7<sup>th</sup> Judicial having the statutory responsibility to appoint said board, and;
- C. The undersigned has been advised that it is now time to make new appointments to the 7<sup>th</sup> Judicial District Planning Board to replace those whose terms have run or who have left the Board for other reasons.

**ORDER**

The membership of the Planning Board shall consist of not less than 10 and no more than 15 individuals and representatives of non-profit entities and organizations involved in youth programs, counseling, education and human services, including but not limited to school districts, municipalities, counties, district attorney's office, mental health providers, departments of social services, law enforcement, and the judicial system. All members, and/or their respective entities, shall be involved with youth within the Seventh Judicial District. The Planning Board members as appointed by the Chief Judge of the Seventh Judicial District shall serve until such time as they may resign or are removed according to the by-laws of the Planning Board. A record of the appointments shall be maintained by the Seventh Judicial District Probation Department.
