**STEPS TO COMPLETE FREE ONLINE PARENTING EDUCATION WORKSHOP**  
**(“Children in the Middle”) FOR PARTIES WITH FILING FEES WAIVED**  
**BY ORDER OF THE COURT**

1. You must have a working email address and access to a computer with the ability to print to take the workshop, which takes 3 to 5 hours to complete. There are parts of the class that include video and sound, so you must have a computer with speakers or headphones.
2. You will need a copy of the Finding and Order Concerning Payment of Filing Fees (JDF 206) that shows the Court has waived your filing fees. The Court would have issued this Order if you filed a Petition or a Response in your case and did not have to pay a filing fee. If you do not have a copy, you can get one from the Court Clerk’s Office.
3. Fill out the Children In Between Online fee waiver request form, which is attached to these instructions.
4. Send the attached fee waiver request form and the Finding and Order Concerning Payment of Filing Fees to the Center for Divorce Education by fax to (740) 594-2521 or by email to [staff@divorce-education.com](mailto:staff@divorce-education.com). The Court Clerk’s Office cannot fax or email documents for you.
5. The staff at the Center for Divorce Education will check your Finding and Order Concerning Payment of Filing Fees against samples of Court Orders they have. If they believe that you qualify, the Center for Divorce Education will email you a pass-code. If there are questions about your request, they will contact the Court to verify that your filing fees were waived by Order of the Court.
6. To complete the workshop, go to the website <http://online.divorce-education.com> and click **Login** in the upper right corner.
7. On the login screen, you will enter the email address you listed on the fee waiver request form that you sent to the Center for Divorce Education. The pass-code that was emailed to you is your password.
8. If you have problems with the login, you can call the Center for Divorce Education at 1-877-874-1365.
9. Your pass-code is valid for 30 days. If you do not complete the workshop within 30 days, there is a \$15 reactivation charge to renew the pass-code.
10. After completing the workshop, you will need to print the certificate of completion and file with the Court Clerk’s Office.
